
#### **Resource Global Global Cohort**

#### Population(s) Served: n/a

We select and train applicants through an eight-month long cohort-based experiential learning that teaches them to think and lead theologically in their spheres of influence. Our comprehensive curriculum covers topics, such as theology of work, Christian identity and mission, leadership, and creation and community care. During the 8-month program, participants have a unique opportunity to learn from their local city director and teaching team as well as from influential Christian leaders in the church and in the marketplace from around the world. Cohort members are also connected with peers and personal mentors who offer support, prayer, feedback, and accountability during the program and beyond. At the end of the program, cohort participants are required to submit a Gospel Action Plan that describes how they will channel their gifts and influence to positively impact their city in response to Christ's call on their lives.


#### Number of people trained


## Total dollar amount of grants awarded

#### **CHARTING IMPACT**

#### What is the organization aiming to accomplish?

Resource Global is committed to providing emerging Christian professionals in major global cities around the world with training and network so they can transform their workplaces and cities for the Gospel. Local leaders in growing cities need solutions and courage to govern well, fight corruption, and develop thriving communities. We believe that the leaders we train have the potential to create justice-filled industries, flourishing churches, help the poor, and start innovative businesses that serve the greater good. Just as Jesus invested in individual disciples so that they can impact the multitudes, we see that God is working through the individual and joint efforts of our cohort graduates to advance human flourishing and transform the world for Christ.

#### What are the organization's key strategies for making this happen?

Our strategy is three-fold: resource, release, and restore.

RESOURCE: We identify emerging Christian professionals in global cities and equip them through our eight-month cohort program that shapes their understanding of faith, work, and their role in God's redemptive mission. We offer Gospel-centered teaching and mentorship at a critical time in their life and career development and connect them into a global community of like-minded peers, cohort alumni, business and ministry leaders who are committed to advancing the Gospel in cities around the world.

RELEASE: At the end of the eight–month cohort program, each cohort participant presents a Gospel Action Plan. These plans lay out the individualized vision of each cohort member to integrate their unique calling, skills, and gifts to make a Gospel impact in their city. We follow-up with alumni to see how the implementation of their Gospel Action Plan is going and try to create quarterly opportunities for the cohort alumni to get together, share updates, and encourage one another.

RESTORE: The restorative work of our team and cohort members are guided by these three values: 1) Gospel-centered (Each person submits to the lordship of Jesus Christ and is directed by the Gospel that is the compass for our lives.), 2) Servant-leaders (We seek the benefit of our cities by empowering and equipping those around us.), and 3) Global bridge-builders (Knowing that the world's needs are great, we commit to working alongside others and helping them to grow in their potential so that real change can be birthed through our creative, unified effort.).

#### What are the organization's capabilities for doing this?

The exceptional quality of our global teachers, mentors, and participants from different cultures, denominations, industries, and ministry experience truly distinguishes Resource Global from other similar ministries and positions us well to achieve our goals. The diverse backgrounds and gifts of our team members and volunteers also add to the matrix of our strengths. In addition to our main cohort program, Resource Global promotes and hosts events that bring together next generation Christian marketplace leaders for workshops on Faith and Work and the changing trends of global missions. For example, in 2021, we hosted 20 virtual global training and networking events that impacted over 700 church and marketplace leaders. Our partnership with dedicated individuals, churches, and other Faith and Work organizations enhances the effectiveness of our program and expands our reach in order to meet our goals.

#### What have and haven't they accomplished so far?

When Resource Global started in 2016, we were a small operation with less than 10 staff members working in only two cities. Today, even amidst the pandemic, we have expanded to 10 international cities (Jakarta,

Indonesia; Medan, Indonesia; Nairobi, Kenya; Singapore; Kuala Lumpur, Malaysia; Pretoria,

South Africa; Johannesburg, South Africa; Hong Kong (virtual); Chicago, Illinois; and Austin) and have trained more than 300 cohort leaders (an average of 12 carefully selected members). We have also grown to a team of more than 25 international staff members and 100 volunteer-mentors during this period. In 2022, we are investing in 100 leaders across all our cities. Our goal is to impact 500 more emerging Christian marketplace leaders in 10 additional cities in the next five years and strengthen our alumni network to support our

graduates in their continuing work.

- -The I<u>RS Automatic Revocation of Exemption List</u> contains organizations that have had their federal tax-exempt status automatically revoked for failing to file an annual return or notice with the IRS for three consecutive years
- -The Foundation Status Code is a value derived by mapping the codes found on the <u>990PF filing instructions</u> to the corresponding codes in the IRS BMF. Note that not all codes are able to be mapped due to insufficient data.
- -The Office of Foreign Assets Control (OFAC) <u>Specially Designated Nationals (SDN) list</u> organizations that are owned or controlled by targeted individuals, groups, and entities, such as terrorists or narcotics traffickers. Their assets are blocked and U.S. persons are generally prohibited from dealing with them.
